RULES AND REGULATIONS

1. Enter Park At Your Own Risk. The City of Manchester and the Manchester Dog Park Assoc. will not be held liable for any injury or damage one may incur by visiting this facility.
2. You are legally and financially responsible for any and all bodily injury or property damage to persons or other animals caused by your dog(s).
3. If your dog bites a human it is automatically and permanently banned from ever entering or using the park.
4. Any dog bites to humans must be reported to the Manchester Health Department within 24 hours.
5. All dogs must wear a proper fitting collar or harness. No spike or choke collars.
6. All dogs must have and wear current registration, vaccination, and membership tags at all times.
7. All dogs must be on leash prior to entering and whenever leaving the fenced area.
9. Each person handling a dog(s) must be 16 years or older.
8. Children under 8 are not permitted and those age 9 to 15 must be accompanied by an adult 18 years or older.
10. No more than 2 dogs per handler at any time.
11. Guests are limited to 1 person per member and their 2 dogs.
12. Handlers must watch their dogs and have them under control at all times.
13. Handlers must leash and remove their dog immediately if it displays any aggressive behavior.
14. Handlers must pick up and dispose of any fecal matter (poop) produced by their dog(s).
15. Handlers are responsible for filling any holes their dog(s) may dig.
16. Dogs under the age of four (4) months and female dogs in season (heat) are not allowed.
17. No animals other than dogs are allowed in this area.
18. No food or glass containers are permitted in the off leash area.
19. Apparatus in the park are for dogs only - patrons are not to climb or play on them.
20. No grooming allowed on premises.

I have read the rules and regulations and agree to abide by them. I understand that violations of these rules may result in the loss of the privilege to use a Manchester Dog Park. Membership may be revoked by a vote of the Executive Committee at any time.

To the fullest extent permitted by law, the member hereby acknowledges and agrees that it shall defend, indemnify, and hold harmless The City of Manchester, The Manchester Dog Park Assoc. and any of its officers, directors, or employees from and against all claims, damages, judgments, liability, losses and expenses, including attorney's fees, arising out of or resulting from the use of the dog park.
